Certification Process

Following receipt of a completed request for quote form, WCS will produce a quote/agreement detailing the costs involved for three years certification. Once the certification agreement has been accepted the stage one is completed ensuring that the system meets the general requirements of the applicable standard and that the scope of certification is correct. When the stage one is complete a written report is provided, and any areas of concern are corrected by the organisation. Once the areas of concern (if any) have been corrected the stage two audit can be planned, and a mutually convenient date is agreed for it to be undertaken.

Stage two audits are undertaken by auditors having the required training, experience and expertise for the industry concerned. On completion of the stage two audit, a written report is provided and a recommendation regarding certification is made. Nonconformances may be raised, and corrective action may be required. Following a successful stage two audit and / or closure of any non-conformances, the organisation is awarded a certificate of registration valid for three years.

Routine surveillance visits are undertaken to ensure the management system is continuing to be maintained. Ongoing certification is subject to these surveillance audits being completed.

Approximately five months before certificate expiry WCS will produce a new certification agreement that includes the recertification audit and further surveillance audits. On acceptance of the new agreement, WCS will complete the recertification audit.
